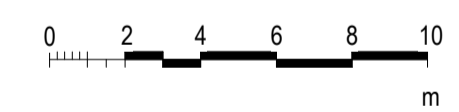


1 Existing Upper Basement Floor Plan

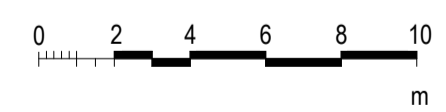

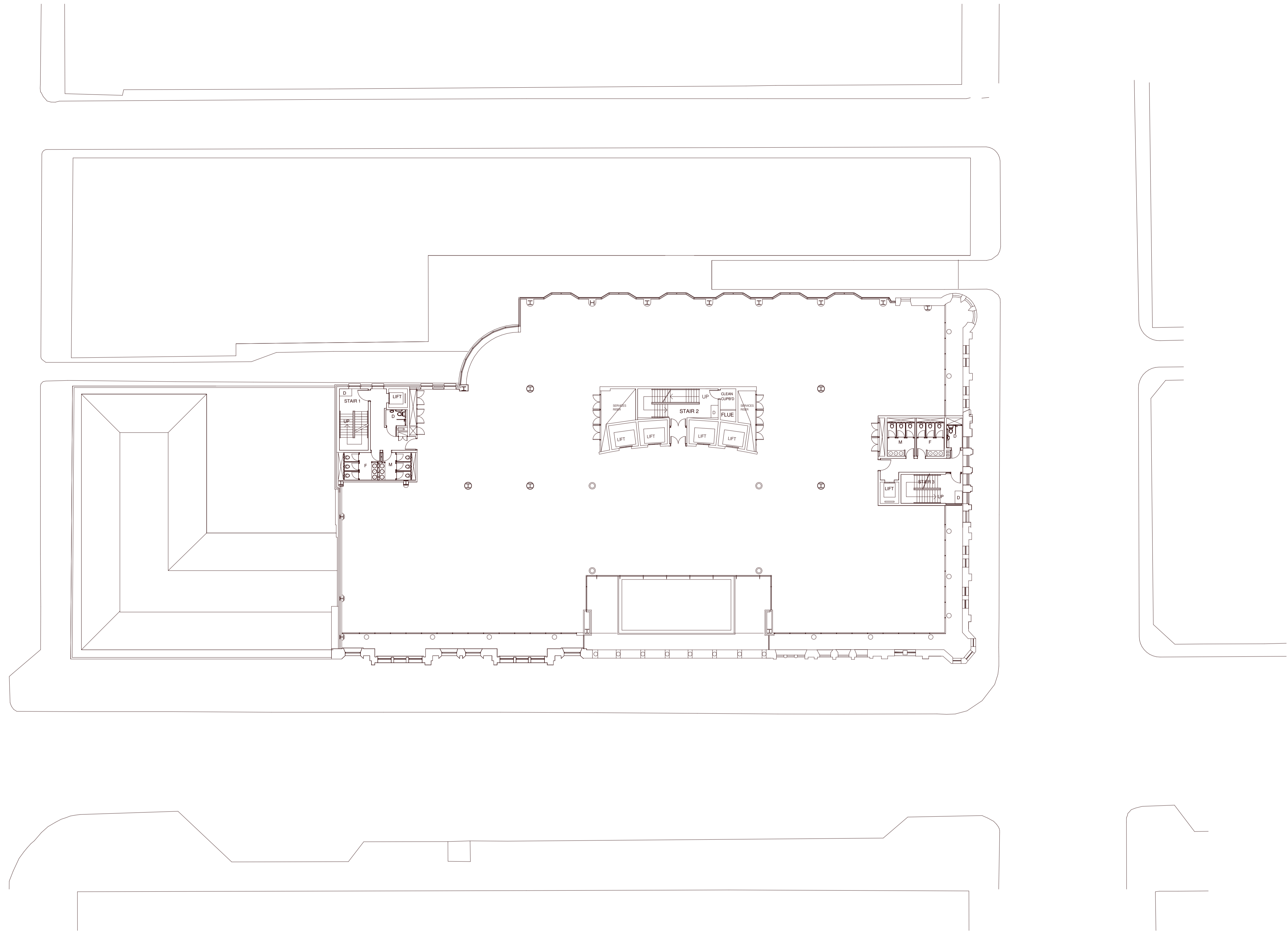

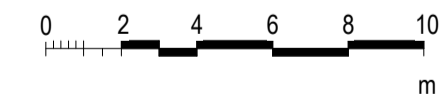
